

## PETITION FOR RECALL

**NOTICE OF INTENTION TO CIRCULATE RECALL PETITION. TO THE HONORABLE ARNOLD SCHWARZENEGGER:**

Pursuant to Section 11020, California Election Code, the undersigned registered qualified voters of the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Governor of the State of California, and to demand election of a successor in that office. The grounds for the recall are as follows: threatening public safety and welfare by grabbing funds from local governments and demoralizing public workers, failing in general to deal with state's major problems as they near crisis proportions, and dismantling public education in California by starving schools of necessary funds while protecting special interest groups of wealthy taxpayers. California should not be known as the state with poor schools, poor healthcare, and poor disaster readiness, all caused by a governor serving only the rich.
